
WARRANTY CERTIFICATE

Limited Product Warranty

Thank you for choosing Verleno Paint Protection Film, manufactured by Verleno TPU Films and installed by your independent dealer. Verleno warrants that the product will not bubble, crack or turn yellow for 10 years from date of purchase. This nontransferable warranty extends to the original purchaser only and applies to the Product purchased for use within the United States of America and Canada.

Warranty Coverage Provided

This warranty is limited to the replacement of defective Product and excludes labor charge to re-apply the Product. All warranty claims are subject to review by Verleno and must comply with all warranty claim requirements as detailed within this Limited Product Warranty.

Care & Maintenance Instructions

To ensure the Product remains in excellent condition year after year, please follow these Care & Maintenance instruction. Failure to adhere to care and maintenance instructions can void Product warranty coverage.

- To ensure Product adhesion, do not wash or wax vehicle for 7 days after installation.
- To prevent staining, remove bugs, sap, tar and fallout from the Product as soon as possible.
- Do not use solvent based bug and tar removers.
- Wash and wax vehicle as needed.
- Only wash with soft non-abrasive wash mitts and drying materials.
- When washing, keep high pressure spray tip 36" away from Product.
- Non-abrasive wax or sealant application is recommenced once every 4 months.
- Do not use polishing compounds, clay bars or waxes that contain dyes or abrasives.
- To remove Product, see Seller for proper and safe Product removal procedures.

Whats not included

General wear and tear: Damages caused by flying rocks and debris will naturally have a wear and tear effect on the film. These films are designed to take this abuse so your vehicle's painted surfaces do not. After time, this wear will become more and more evident. This is not warranty. These films however, are very resilient and stand up well for years.

Customer damage: Pressure washer accidents. Buffer accidents. Damage from strong solvents. Manually peeling up film. Manually scratching the film. Damage to your vehicle from flying rocks and debris: Warranty in no way covers any portion of the customer's vehicle itself. These films are resilient, but not invincible. Any flying projectile over a certain

velocity may puncture the film, the vehicle's paint or glass surfaces. These are not warranty. Other Parties: Any damage to the film caused by third parties such as auto body shops, service shops, etc.

Limitations

Warranty coverage is only provided for Product installed in accordance with the installation procedures referenced in the Verleno Product Installation Manual and maintained in accordance with the Verleno product care and maintenance instructions. This limited Product warranty does not apply to any damage to the Product, the vehicle and/or its painted surface, caused by accident, physical impact, harsh chemicals, fallout, acts of God, normal wear and tear degradation, or abuse from power washing, buffing, polishing or detailing. Fresh paint must cure a minimum of 90 days before installing the Product and this warranty does not include coverage for paint peeling in the event Product is removed. Improper product installation and Buyer's failure to adhere to Verleno directed product care and maintenance instructions will void product warranty coverage.

Disclaimers & Exclusions

Liability of Verleno/ installer is limited to the warranty provided herein and no other warranties or representations are provided. No person, distributor, agent, dealer or professional installation company is authorized to modify, change or extend the terms of this limited warranty or to assume or create any obligations or liabilities for Verleno or Seller. This warranty may provide specific legal rights that can vary from State to State or Province to Province. This warranty shall be construed by the laws of the State of Maryland, United States, without regard to conflict of law principles.
